A BRIEF OVERVIEW OF DCED'S MUNICIPAL STATISTICS

WHAT IS MUNICIPAL STATISTICS?

Comprised of data collected from local governments through the following legislatively mandated annual filings:

- Tax Information Form
- Report of Elected and Appointed Officials
 - Survey of Financial Condition
 - Annual Audit and Financial Report
- Annual Report of Municipal Authorities and NIDS

HOW MANY REPORTS ARE RECEIVED?

- Tax Information Form (2558+67+500)
- Report of Elected and Appointed Officials (2558+67)
 - Survey of Financial Condition (2558+67)
 - Annual Audit and Financial Report (2558+67)
- Annual Report of Municipal Authorities and NIDS (1886)

Total: 12,886 Reports (avg 35 reports a day, year-round)

HOW DO WE COLLECT THE DATA?

Each report must be submitted via the
Municipal Statistics e-filing system:

<https://apps.dced.pa.gov/munstats-forms/login.aspx>

DCED sends an annual Notice-to-File to all local governments, listing each report and due date.

WHAT DATA IS COLLECTED?

Tax Information Form

(municipalities: DCED-CLGS-2565, counties: DCED-CLGS-67,
school districts: DCED-CLGS-501)

Collect every tax type and rate for municipalities,
counties and school districts.

Made available to the public.

Tax Information Form (cont)

Feeds the Official Tax Register, which provides the Political Subdivision (PSD) code along with the employee's EIT and LST rate and tax collector information.

[Official Tax Register](#)

The Official Tax Register is released twice a year:

June 15 for withholding taxes effective July 1.

December 15 for withholding taxes effective January 1.

Report of Elected and Appointed Officials

(municipalities: DCED-CLGS-19; counties: DCED-CLGS-18)

- Collect name and contact information for the most common elected and appointed officials.
 - Number of FT and PT employees
 - Police service, along with FT/PT employees
 - Fire service, along with FT/PT employees
- Municipal planning, zoning and building code Information

Report of Elected and Appointed Officials (cont)

Submission of this form is required before a municipality receives its Liquid Fuels disbursement.

Made available to the public.

Survey of Financial Condition (DCED-CLGS-69)

Internal document that helps determine a municipality's financial stability.

Submission of this form is required before a municipality receives its Liquid Fuels disbursement.

Not available to the public.

Annual Audit and Financial Report

(municipalities: DCED-CLGS-30; counties: DCED-CLGS-20)

Collect financial data for all municipalities and counties.

Contains a balance sheet, itemized revenues and expenses, debt statement, and total employee wages.

Made available to the public.

Annual Report of Municipal Authorities and NIDS

(DCED-CLGS-04)

Collect financial data for all municipal authorities formed under the Municipal Authorities Act of 1965.

Recently began collecting Neighborhood Improvement District financial data as well.

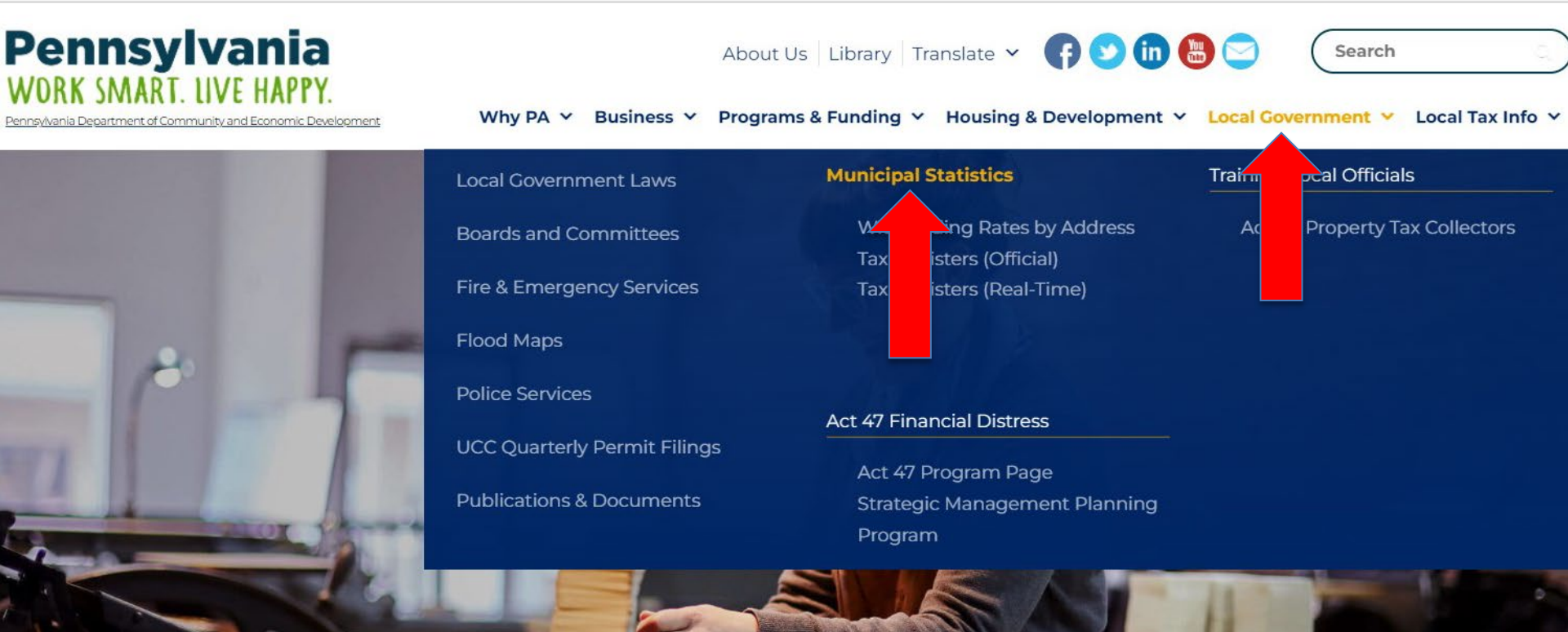

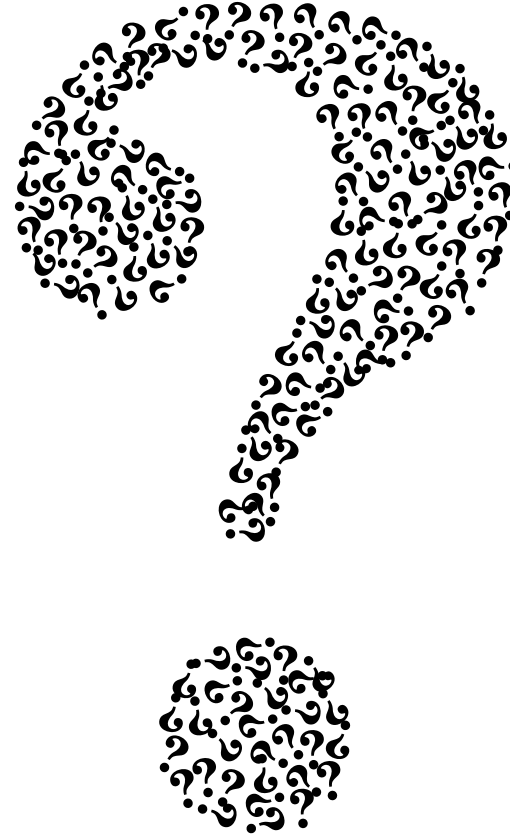
